Cllr. Heathcoat supplied a written report which was received and NOTED.

4) District Councillors' Report

Cllrs. Cox and Kainth supplied a written report which was received and NOTED. Parking was raised by the meeting as still being an issue in Faringdon. Cllr. Cox explained that this was a police issue. The meeting questioned why the district had not introduced civil enforcement. Cllr. Cox explained it would involve both County and District Councils and would cost approx. £250k to introduce. Cllr. Cox was asked to provide a breakdown of these costs which he would supply to the Town Clerk for publication.

5) Thames Valley police – Sgt. Ryan James supplied a written report which was received and NOTED. The meeting questioned Sgt. James why parking was not enforced in Faringdon. The public were encouraged to take pictures of and report offenders. However police resources were tight and the police had to prioritise serious crime.

6) Reports from Local Organisations

- Children's Centre Faringdon– Carole Gough, Manager, supplied a written report and gave a short presentation which was received and NOTED. The presentation highlighted how the closure of the Children's Centre, as a result of cuts made by Oxfordshire County

Council, would affect Faringdon's families, in particular vulnerable Families. The Children's Centre staff were very worried about the five universal groups they run no longer being available as they acted as an early intervention tool. Statutory safeguarding would continue but it was questioned how this need would be identified, particularly as the nearest Children's Service would be in Abingdon. A member of the public suggested that volunteers from Home Start could provide support. Mrs Gough explained that the volunteers carry out a wonderful service but were currently only helping Military families in the town and would not be able to run the universal groups.
