8/4/16 Vale of White Horse District Local Plan – Stage 2 Hearings

The Chairman reported that he had attended the Hearing on 17 February which concerned District Wide Policies and that particular interest to Town Council was Matter 12.2, "Are the policies relating to supporting economic prosperity soundly based?". The Chairman stated that there had been very little opportunity for him to be able to make comments as the thrust of the discussion was towards the Eastern Vale although he was able to make a contribution about the high level of social housing in Faringdon as compared to Abingdon and Wantage.

9/4/16 Faringdon Neighbourhood Plan (FNP)

The District Council had now advised that the appointed Independent Examiner (IE) had decided, for a number of reasons, that he could not undertake the re-examination of the FNP. The District Council would be contacting NPIERS to ask for their suggestions for appropriate individuals who would be suitable for undertaking the re-examination but to date the District Council had not advised Town Council of any available candidates. If a list was received between future scheduled meetings of the Planning & Highways Committee, it was AGREED that in order to move swiftly on a decision, an Extraordinary Meeting be held.

In view of his anticipation of the further delay caused by having to appoint another IE and the subsequent time it would take for the IE to examine the FNP and to draw up a report, the Chairman had postponed the inaugural meeting of the FNP Working Party. However, following discussion, it was AGREED that a meeting of the FNP Working Party should nevertheless still be held in order to discuss a strategy to put in place for promotion of the FNP to the local residents. Cllr Middleton was delegated responsibility for drawing up an appropriate agenda.

It was FURTHER AGREED that a letter should be sent to the Secretary of State outlining Town Council's discontent with the way the District Council has dealt with the FNP.

10/4/16 Bus Stops

- (a) New bus stops, Coxwell Road: OCC had advised it is still waiting for the Section 278 works to be completed. Once these are completed, OCC will inspect and sign off assuming all is in order. At that time the developers would need to pay the Commuted Sum which covers the bus stops;
- (b) Possible installation of a further bus stop between the bus stops in Park Road and the Market Place: Town Council had requested OCC to consider this request in 2013 but since then no forward progression had been made and the request had subsequently been chased up by Town Council at the end of February this year. OCC has now advised that in the light of the C/Cllr's response that indicated that both sites were inappropriate, this request had not been progressed. It was AGREED that Cllr Dr Wise, together with the Deputy Town Clerk, would write to OCC again reiterating the need for a bus stop in the area requested.
