OBJECT on the following basis:

- 36 dpha is higher than Faringdon Neighbourhood Plan density;
- Three storey houses are proposed in the Central Green Area; this is contrary to the Great Coxwell Neighbourhood Plan, (in fact, is more in keeping with the built up area of Faringdon) and is not consistent with a rural approach to Faringdon. This was pointed out at the consultation with the developers and Great Coxwell Parish Council on 13 June 2016 but has not been modified. This contradicts a made Neighbourhood Plan;
- All houses should have optical fibre connections to the point of access;
- Houses should include passive and photovoltaic panels;
- Plain red brick should be avoided; a patterned mixture of red and blue brick would be more consistent with the architecture of this area;
- Surfaces need to be porous to prevent flooding;

 - Great Coxwell Neighbourhood Plan, policy NDS9;
 - Faringdon Neighbourhood Plan New areas of housing

In addition to the above objections, Faringdon Town Council wishes to raise the following queries:

- 1. Allotments: Policy 4.10C of the Faringdon Neighbourhood Plan sets out a requirement for housing developments over 20 dwellings to contribute either to on- or off-site allotments. What is being done with regard to provision of allotments?
- 2. Who will be responsible for long-term site maintenance eg green spaces?
- 3. From the diagrams it looks like the Structured Landscape Buffer Zone and Protected Animal Habitat has gone? Please could this be retained?
- 4. What are the plans for a fence or equivalent for the boundary next to Tollington Court?
- 5. The former owners of Fernham Fields stated an intention of providing £100k from this development towards a Town Centre Regeneration Manager. We understand that S106 is written as part of a land agreement and therefore remains in place

if/when land is sold on. Is this money part of the S106 agreement?

6. We understand that LPAs, in some cases, are now requesting an Employment and Skills Strategy from developers as a pre-commencement condition, use of local trades/ work placements, etc. Is this something that the District Council will be requesting?

8/11/16 Vale of White Horse Local Plan 2031 Part One

The Schedule of Main Modifications includes a series of changes to the published Local Plan 2031 Part 1 and the Inspector is inviting comments on the proposed Main Modifications.

It was AGREED that this Schedule would be reviewed and discussed further by the committee at its next meeting due to be held on 23 August, any comments to be submitted to the District Council by the deadline of Wednesday, 14 September 2016.

9/11/16 Vale of White Horse District Council – Statement of Community Involvement Consultation

The above consultation is being held by the District Council. It was AGREED that the Draft Statement would be reviewed and discussed further by the committee at its next meeting due to be held on 23 August, any comments to be submitted to the District Council by the deadline of 14 September 2016.

10/11/16 Faringdon Neighbourhood Plan (FNP)

It was NOTED that a public hearing had been held on the 18 July 2016 at the request of the Independent Examiner in order for him to ensure adequate examination of the proposed designation of Humpty Hill as Local Green Space had been undertaken..

It is understood that the Independent Examiner's draft report on the FNP has been completed and will now be submitted formally to the District Council.

It was NOTED that yet again, a S278 Agreement had been drawn up by Oxfordshire County Council, this time with the developer of the 4&20 site to install new bus shelters Faringdon, without any consultation with the Town Council. Town Council only learnt about the bus shelters when it was contacted by the agents to ask what colour the bus shelters should be, the style of bus shelter having already been technically agreed as part of the S278 arrangement.

Town Council understands that under S278 rules there is no statutory requirement for consultation with the parish council; however, it feels very strongly that parishes should be involved at an early stage when their local knowledge could be beneficial. The point has now been raised with C/Cllr Mrs Judith Heathcoat who is looking into the matter.

It had also been indicated by the agents that future maintenance of the new bus shelters would be the responsibility of the Town Council. OCC has not discussed funding for future maintenance of these bus shelters by Town Council and this matter has yet to be resolved.

Town Council has been asked to indicate what colour it would like the two new bus shelters on Park Road to be. It was AGREED that they should be green to match the other green bus shelters in Faringdon.

12/11/16 Changes to the Vale of White Horse District Council Constitution – Planning Scheme of Delegation

District Council recently held three training sessions for Parish Councils regarding the above changes and had advised that a report covering the outcome of these sessions would be circulated to all Parish Councils. It was NOTED that Cllr Andrew Marsden, Cllr Dr Mike Wise, the Town Clerk and the Deputy Town Clerk attended the training session in Faringdon. A copy of the briefing notes would be circulated to the committee members for their information.
