Signs

Members considered a quote for installing signs on all Town Council Parks with emergency contact details. Members were informed that a further quote was expected. It was further PROPOSED that the Clerk contact the Tree Officer to clarify if works suggested on the Willes Close protected trees could be carried out. This was CARRIED.
