Consultation on draft Vale of White Horse CIL Spending Strategy

It was noted that the Vale of White Horse District Council is inviting comments on its draft Community Infrastructure Levy (CIL) Spending Strategy. It was proposed and agreed that the Town Clerk should submit town council's response, deadline 11 February.

Safety Issues - A420

A brief report was received from Cllrs Marsden and Dr Wise who had attended a meeting on 18 January with Ed Vaizey MP and other representatives from local parish councils near the A420.
