7/1/16 Youth Groups Update

a) Members received and NOTED an update from Kealy Whenray of the Pump House Project which highlighted:

- A disabled loo had been installed in the PHP and this was almost completed.
- The project was encouraging community groups to use the venues rather than commercial ventures.
- New projects running from TPHP include:
 - o Open Access Youth Group Faringdon Town Council
 - Drop in Youth Dance Classes TPHP
 - Children's Yoga
- A Youth Arts festival is being planned working in partnership with Faringdon Town Council Youth Services
- Parkour sessions are planned for School Holidays
- b) To receive an update from Faringdon Rotary Club Members were informed that Rota Kids is successfully running in TPHP. There has recently been a change in the Youth Section of Rotary and the new Youth Services link will be invited to the next meeting.
- c) Members received and NOTED an update from Tim Vinal of Faringdon Scouts which highlighted:
 - A seconded section of Beavers and Scouts had been launched in the Barber Rooms and was running successfully. The young people had chosen the names for the new groups – Folly Foxes and Folly Wolves.
 - Scouts will be attending a National Camp in London on the weekend of 9/10 Jan.
 - Events were being planned to celebrate 100th year of cubs.
- d) Members received and NOTED an update from Rebekah Pugh Faringdon Town Council Youth Services which highlighted:
 - New session for Young Activity Auditors was being launched with members for different youth groups.
 - FTC Senior Youth Worker is working in school promoting a variety of Youth Services in the town.
 - FTC Youth Services are working well from a variety of venues in the Town centre.
- e) No update from Faringdon Baptist Church Youth Group was available.

No further update. The Clerk reminded all Youth Groups to come forward to the Town council if they wanted a project included in any future bids.

9/1/16 Faringdon Youth Services

- a) Members received a management update report from Youth and Community Officer, Rebekah Pugh which was NOTED with thanks. The report highlighted:
 - Youth Services is operating very well from FTC Venues
 - New drama session has been launched
 - New open access group to start in January at Pump House Project
 - School Outreach working well
 - 789 contacts with young people have been made in the last month by the Youth Services team
- b) Members considered the future location FTC Youth Services Following reports that Youth Sessions were successfully operating away from FAZE, it was PROPOSED that a recommendation be made to Council that Youth Services vacated the FAZE site and continued to operate their sessions in other venues in the Town Centre. This was SECONDED and CARRIED.
- c) Members considered purchasing two laptops for Youth services staff. It was PROPOSED that the Clerk be given a budget of £600+VAT from the Operating Reserves for Youth Services to purchase the laptops. This was SECONDED and CARRIED.
- d) Members received a financial report to 30th November 2015. This was NOTED.
- e) Members considered the budget for 2016/17. It was PROPOSED that the Youth Services presented a budget with the FAZE building Costs removed to the Finance and Audit Committee. This was SECONDED and CARRIED. The final revenue budget for Youth Services was AGREED at £10,380.
