8/5/16 Faringdon Neighbourhood Plan (FNP)

(a) The Chairman reported that a meeting, held on 29 March between Cllrs Andrew Marsden, Dr Mike Wise, senior planning officers from the District Council, D/Cllr Roger Cox, with the Deputy Town Clerk in attendance, had discussed the recent delays in the processing the FNP (acknowledged by the District Council as due to staff shortages) and its future progression towards referendum. The meeting had been positive, covering how the next steps towards the appointment of an Independent Examiner and the subsequent actions that would follow should be controlled. If the examination passed off without problem it was hoped that the referendum could be held on a date between the Police & Crime Commissioner election on 5 May 2016 and the EU referendum on 23 June 2016.

- (b) A list of three possible candidates for the role of Independent Examiner had just been received by Town Council from NPIERS (Neighbourhood Planning Independent Examiner Referral Service). In order that an IE could be appointed as soon as possible, it was proposed, seconded and CARRIED that authority be delegated to the Chairman, Vice-Chairman, Cllr Dr Mike Wise and the Deputy Town Clerk to select the IE and to advise the District Council of Town Council's choice by Thursday, 31 March 2016. It was agreed that the relevant CVs should be circulated to all members of the Planning & Highways Committee for any comments they may wish to make before a final decision is made.
- (c) Draft Minutes of the inaugural meeting of the FNP Working Party held on 22 March 2016 were received and NOTED. The next meeting was scheduled to be held on 5 April.

9/5/16 Bus Shelter, Coxwell Road

It was NOTED that one of the upper side panels in a bus shelter in Coxwell Road had been damaged due to vandalism.

It was proposed, seconded and CARRIED that the whole side panel be replaced with a mesh panels supplied by Spacemaster at a cost of £325 + VAT and that the possibility of any insurance claim be followed up by the Deputy Town Clerk.
