They state that "condition 11 (drainage details) cannot be discharged until the completion of the upgrade works at Faringdon Sewage Treatment Works (STW) which is scheduled to be completed by the end of March 2018". Town Council would like clarification on this point, ie will the STW actually be completed by the said date or will there be some form of tankering off site or other means of drainage?</p> |

| | <p>P17/V1082/O – Land South of Park Road, Faringdon Amendment on application as per updated Biodiversity Calculator received 27 November 2017. NO OBJECTIONS However, when town council was considering this amendment, it noted from comments submitted by Oxfordshire County Council in respect of the full planning application (P17/V1082/O-3) that it is seeking S106 funding of £428,503.20 towards the delivery of improvements to the Swindon to Oxford bus service (Stagecoach 66). Town Council feels very strongly that funding should be provided to extend the bus service from Faringdon to Wantage (Stagecoach 67), a service that is in need of improvement, as well as providing funding towards improvement of the community bus (61) in order that it too can offer a better service around the town, especially given the expected large increase in residential properties.</p> <p>P18/V0097/HH – 1 Sudbury Court, Faringdon Proposed two storey side extension and internal modifications For: Mr & Mrs Boyd NO OBJECTIONS</p> |
