# **Community & Partnerships** Committee – 30<sup>th</sup> September 2024

Town Councillor Surgeries have been a success and will continue to operate in 2025. Again, these will be indoors in the winter and outside in warmer months. Please join us on Saturday 2<sup>nd</sup> November

### August Play Day, **Tucker Park:**

Councillors agreed to take part in this again next year but to organise a separate activity for children under the Faringdon Town Council (FTC)



gazebo. Councillors approved the programme and budget for Christmas Lights On event on 30th November and look forward to helping at the event. The councillors agreed to set up a working party to investigate whether the Tourist Bus will run in summer 2025. Following the success of the Open Air Cinema, councillors agreed to hold this again in 2025.

## Full Council – 14<sup>th</sup> October 2024

It was agreed that the Town Clerk will write to SSE to raise the problem of streetlighting on Highworth Road not working. The Council considered (and supported) a planning application for a proposed Special Educational Needs and Disabilities (SEND) School at Lechlade Road. Organisation of a new Art Bench trail is coming together. These 8 new themed benches are being funded from local developments and will be located around the town. More to follow in due course.

### Planning and Highways – 21<sup>st</sup> October 2024

Bloor Homes (Oriel Gardens) proposed amendments to play equipment for the development which FTC strongly objected to as the proposed play equipment is inferior to the previously approved NEAP (Neighbourhood Equipped Area for Play) equipment. FTC want to return to the original specification and add two more pieces of apparatus and ensure some equipment is designed for inclusive play. Members considered correspondence regarding poor walking and cycling connectivity in the town, notably between housing estates. The Town Clerk will work with the Vale Planning Officers to investigate ways to improve connecting paths.

Peter says "2024 is a special year for me: I will be celebrating my 90th birthday this month, but more importantly, back in May of this year I was fortunate in being able to take part in Faringdon Art Society's exhibit for Oxford Artweeks.



Having always considered Artweeks to be another selling opportunity to the wider public, I didn't appreciate that it is so much more - an opportunity for other artists to view, discuss, and generally critique the displayed work of their fellow creators. I used the time at the Old Town Hall to work on a new, and quite difficult, Christmas depiction of Dusk in Faringdon's Market Square and was blown away by the wonderfully appreciative comments.



To think that I still have this sort of recognition from my peers is very humbling and really means such a lot to me.

Going forward I'm not sure how much longer

I shall be able to paint to my own standard, but this year there are three winter themed cards, a Christmas Walk at The Folly, and two new views of our pretty Market Square, together with all the previous favourites of course. These new additions have already proved enormously popular, and reprints are on their way".
