## **Round-Up of Local Issues**

Not all items are covered here, with a selection of the main updates listed below. Please get in touch for further details on these or other items.

- New Damaged Wall, Bottom of Stanford Road: We are happy that the Town Council are investigating ownership of this wall. We will act if necessary.
- New Equipment, FLC 15 new spin bikes have been purchased by the Vale of Whitehorse District Council. This are due to be active this week.
- **Decarbonisation, FLC** Awaiting connection date.
- Artificial Turf Pitch, FLC: No further information to report.
- Wessex Leisure Funding We are checking with OCC that the funding was allocated in their 25/26 budget. This funding would be transferred to Vale and ringfenced.
- Lighting, Gloucester Street Car Park Awaiting date for the permanent fix.
- Fernhill Gardens to Belmount Estate A date has been scheduled a walk around site visit to check pavements and link pathway.
- Wicklesham Farm Still waiting on a date Oxfordshire County Council's planning committee.
- SEND School Application We are planning an update meeting with the planning officer.
- Wain Homes/Coxwell Road Following up on reports of mud on road and parking.
- Folly Park Paths & Car Park Already investigating if improvements can be made and issues around adoption, particularly of car park, and pedestrian/cycle bridge.
- Great British Spring Clean We are happy to be involved in GBSC, and very supportive of town council approaching district for a Spring Clean pack.

## **District Update**

#### Social housing allocation policy changes

Our public consultation on proposed changes to the Joint Housing Allocations Policy opened on 18 February. The policy underpins our work on providing homes to those who need them most, setting out the criteria to join the housing register and the rules for how social housing is allocated.

Last updated in 2019, the policy needs refreshing to reflect current housing priorities in the districts. There are four main proposed changes to the policy – all designed to help ensure no one is disadvantaged when it comes to allocating social housing.
